### The Real ID Challenge

Real ID requires more stringent documentation for identification purposes. With that comes challenges for DMVs and other organizations processing Real IDs. For one, many of the required documents, such as passports, pose a challenge for scanning due to the thickness or condition of the document. Additionally, the guidelines call for digital images of each document to be stored in each state's DMV database.

- How do you capture, validate and maintain all of these different types of documents?
- How do you remain compliant with the collection and storage of personal data?

### What is Real ID?

The Real ID Act of 2005 is a U.S. federal law requiring U.S. citizens to have a compliant ID that has gone through a more rigorous validation process. These new requirements are intended to prevent tampering, counterfeiting, or duplication of the document for fraudulent purposes. Real IDs will be required for official purposes such as boarding commercially operated airline flights, and entering federal buildings and nuclear power plants.

### What Data Is Required?

A Real ID-compliant form of identification requires the following:

- Full legal name
- Signature
- Date of birth
- Gender
- Unique identifying number
- Principal residence address
- Front-facing photograph of the applicant



### What Documents Are Needed?

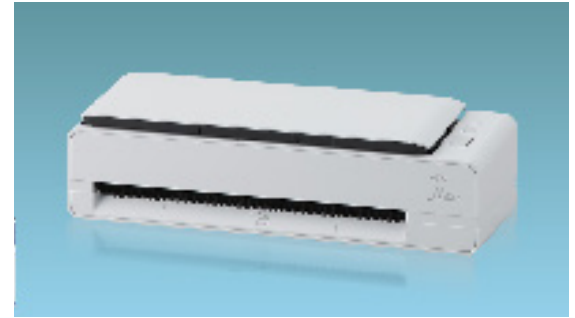
Applicants must provide the following documentation:

- A photo ID, or non-photo ID that includes full legal name and birth date
- Documentation of birth date
- Documentation of legal status and Social Security number
- Documentation showing name and principal residence address
